I am directed to state that based on the consultations with the concerned State Govt., the concerned affiliating body and on recommendations of the sub-committee of the concerned All India Board of Management Studies and, the Expert Committee constituted by the Council and as per the provisions of AICTE Act and its regulations, the All India Council for Technical Education (AICTE), is pleased to accord approval to P.A.EDUCATIONAL TRUST (R) PEEYE'S HOMES, STURRACK ROAD, FALNIR, MANGALORE-575001 for establishment of P.A.COLLEGE OF MANAGEMENT NADUPADAV, KAIRANGALA VILLAGE BANTWAL TALUK MANGALORE - D.K.-574153 , for the academic year 2001-2002, for course(s) and intake as given below with specific condition that admission shall be made through the central Counselling by the Government of Karnataka only. This approval is valid only for the academic year 2001-2002 and cannot be extended for the next year 2002-2003.
